By entering, you are providing your information to Cincinnati Bell and not to Facebook, Twitter or Instagram.** Sweepstakes open to participants who are 18 years or older and residing in Cincinnati Bell's operating area in Ohio, Kentucky, or Indiana as of the date of entry. All entrants and winners agree to abide by Ohio law and the Official Rules governing this contest. ## How to Enter

Registration Form (or mail-in document) must be completed in its entirety and will be deemed ineligible to win if any information is missing or incorrect. Submissions will be automatically entered to win. Limit one entry per person. ## Duration

Sweepstakes begins on August 24<sup>th</sup> at 1pm EST, and ends at 8AM on September 3<sup>rd</sup>, 2021 ("Sweepstakes Period"). Only entries received by 8AM EST on September 3<sup>rd</sup>, 2021 will qualify.

## Publicity/Privacy

All entries become the sole property of Cincinnati Bell. By accepting a prize, winner agrees to Cincinnati Bell's use of his or her name, voice or likeness without further compensation.

## Eligibility

Sweepstakes open to participants who are 18 years or older and residing in Cincinnati Bell's operating area in Ohio, Kentucky, or Indiana as of the date of entry. Employees (and their family members) of Cincinnati Bell (and its respective parent companies, subsidiaries, affiliates, and their advertising and production agencies) are not eligible to enter. Winners may be required to sign an affidavit of eligibility to certify that they meet the eligibility requirements.

## Random Drawing

One (1) entry will be selected in a random drawing at 9 AM EST on September 3, 2021, from all eligible entries received during the Sweepstakes Period. The winners will be contacted between September 3 and September 8<sup>th</sup>, 2021. If a selected entrant cannot be reached by phone or email after the third attempt, that entrant shall be disqualified and an alternate entrant may be selected. The odds of winning will depend on the total number of eligible entries received during the Sweepstakes Period.

## Prize

One (1) prize will be awarded to 3 separate winners (either 6 tickets to Coney Island, 2 VIP tickets to Dead & Co at Riverbend Music Center, or 4 tickets to the September 17<sup>th</sup> Reds game). No cash or other substitution or transfer of prize permitted, except by Sponsor, who reserves the right to substitute a prize with another prize of greater or comparable value.

## Winners

By entering this contest, the winner agrees to hold forever harmless of any liability whatsoever, Cincinnati Bell and any other sponsors of this sweepstakes, including their employees, affiliates, parent companies, agencies, and subsidiaries, from damages of any type or kind that may occur or arise from the acceptance and/or use of this prize. Each winner further agrees to allow the participating sponsors the opportunity to use his/her name and/or photograph(s) for publicity for this sweepstakes.

## COVID-19

Due to the recent surge in Covid-19 cases, many of the venues that Cincinnati Bell partners with are requiring proof of vaccination or a negative Covid-19 test result prior to entering their venues. As a result, Cincinnati Bell sweepstakes winners must adhere to each venue's entry requirements. The policies are being enacted to safeguard the health of fans and to prevent another shutdown, if possible.

Requirements going into effect on October 4th, 2021:

- All fans must be fully vaccinated against COVID-19 (at least two weeks after final dose) and provide proof of vaccination - either the original vaccination card or a PRINTED copy of the vaccination card with an appropriate ID matching the name on your documentation. OR have received a negative COVID-19 diagnostic test within 48-hours before the event and provide proof of negative result to security prior to entering the venue.
- Unvaccinated fans under 12 years of age will be required to take a COVID-19 diagnostic test within 48-hours before the event and will provide proof of negative result to security prior to entering the venue.
- Unvaccinated fans over 12 years old with a valid medical restriction & medical note will be required to take a COVID-19 diagnostic test within 48-hours before the event and will provide proof of negative result to security prior to entering the venue.

## Taxes

Winner is solely responsible for reporting and paying any and all applicable federal, state, or local taxes.

## Miscellaneous

If a winner cannot be contacted, is ineligible, fails to claim or fails to timely complete, properly execute, and return any requested affidavit(s) and/or release(s), that winner's prize will be forfeited and an alternate winner may be selected.

## Limitation of Liability

Entrants release Cincinnati Bell and any affiliated entity, and their officers, directors, employees and agents from any and all liability, damages or causes of action (however named or described) for injuries, damages or losses to persons, including death and property which may be sustained in connection with receipt, enjoyment, ownership or use of the prize(s).
